Weigh ins Saturday, November 17, 2012: 8:45 AM – 9:30 AM, ****No Allowance****,
We expect to run until 6:00 pm on four mats, so we need everyone's cooperation to keep the matches moving.

Roster Rules: Rosters must be sent to Fred Mills by November 3rd and can be to be finalized at weigh ins if any changes, if a team lends a member of their team to another, that wrestler must remain with the new team through out the competition, unless another wrestler from their original team is injured and removed from further competition, by the trainer. The switch back will not be allowed if original team and the team that got the lent wrestler are competing when the switch back is requested. Example: Dan Gable from Danbury Pal is lent to Northeast Elite . John Smith from Danbury is injured and removed from the competition, Dan Gable returns to Danbury Pal, unless Danbury Pal is wrestling Northeast Elite when the switch back is requested.

Format: Two pools of 4 teams - wrestle all teams in assigned pool. Based on pool record, the semi-finals will be wrestled against the opposite pool. (1 v 2) (2 v 1), those winners wrestle for the Championship and the losers wrestle for Third .

Tie breaker rules: In the event two teams have the same record in a pool, the first tie breaker is head to head results and in the event three team have the have the same record in a pool, total match points earned in pool competition will determine the ranking of the three teams.

The 3rd and 4th place pool finishers will cross and wrestle against the opposite pool. (3 v 4) (4 v 3), those winners wrestle for 5th . Each team will be guaranteed five matches and we will have placement for top eight teams.

Matches: All Periods are 1 minute.

Awards: Team trophies for 1st, 2nd & 3rd place teams.

Concessions: Available all day

Admission: All spectators over the age of 14 and under the age of 65 will be required to pay \$3.00. except (Head Coach, team scorer & 2 Assistant Coaches Free with complimentary admission passes)

18 Wt. Classes: 45 – 48 – 52 – 55 – 59 – 63 – 66 – 71 – 74 – 79 – 82 – 86 – 90 – 96 – 100 – 110 – 120 – HWT(Max. 150)

Wrestlers may move up one weight class from registered weight class.

Roster Rules:

Rosters are to be finalized at weigh ins, if a team lends a member of their team to another, that wrestler must remain with the new team through out the competition, unless another wrestler from their original team is injured and removed from further competition. The switch back will not be allowed if original team and the team that got the lent wrestler are competing when the switch back is requested. Example: Dan Gable from Danbury Pal is lent to Northeast Elite. John Smith from Danbury is injured and removed from the competition, Dan Gable returns to Danbury Pal, unless Danbury Pal is wrestling Northeast Elite when the switch back is requested.

Bumping up of wrestlers is limited to one weight class.

Weigh-ins:

Saturday, November 17, 2012: 8:45 AM – 9:30 AM, **No Allowance**

Seeding Selection:

Tournament Director will do their best to balance the pools.

With 5 rounds and 18 weight classes there is no room for delay.

Scoring:

Scoring will be based on the following criteria:

Forfeit / Injury / Disqualification	6 Points
Fall / Pin	6 Points
Technical Fall (12)	5 Points
Major Decision (8)	4 Points
Full Bout Decision	3 Points

Final / Consolation Seeding:

Advancement to the championship round will be based on your pool record. The team with the best pool record in pool A will meet the team with the second best record from pool B and the team with the best pool record in pool B will meet the team with the second best record from pool A, this will be called the Semi-Final round.

In the event two teams have the same record in a pool, the first tie breaker is head to head results and in the event three teams have the same record in a pool, total match points earned in pool competition will determine the ranking of the three teams.

The teams that placed third and fourth place in their pools will then wrestle a Consolation Semi-final match in which the team with the 3rd and 4th place pool finishers will cross and wrestle against the opposite pool. (3 v 4) (4 v 3), those winners wrestle for 5th.

Championship match will be the winners of the Pool cross over Semi-final match and the losers of the Pool Cross over Semi-Final Match will wrestle for Third place.
